

# 2025 MID-EAST MODIFIED TOUR RULE BOOK.

# A NOTE FROM THE SANCTIONING BODY:

A MID-EAST MODIFIED TOUR EVENT IS A COMPETITIVE RACING EVENT, WHICH IS INTENDED TO BE CONDUCTED AND OFFICIATED IN ACCORDANCE WITH THE RULES HEREIN (THE 2025 MID-EAST MODIFIED TOUR RULE BOOK). THESE RULES PROVIDE GUIDELINES FOR ALL EVENTS. THE RULEBOOK MAY BE AMENDED FROM TIME-TO-TIME AND SPECIAL RULES MAY BE PUBLISHED AND/OR ADJUSTED AT ANY EVENT WITH THE PARTICIPANTS RECEIVING PRIOR NOTIFICATION. BY PARTICIPATING IN THESE EVENTS, ALL PARTICIPANTS AGREE TO COMPLY WITH THESE RULES AND REGULATIONS. THE RULES ARE NOT INTENDED TO EXPRESS OR IMPLY THE WARRANTY OF SAFETY OF HARDWARE OR SOFTWARE AS A RESULT OF PUBLICATION OF, OR COMPLIANCE WITH THE RULES AND REGULATIONS AS STATED HEREIN. THE RULES ARE INTENDED TO OFFER A GUIDELINE FOR THE CONDUCT AND OFFICIATING OF AN EVENT. THE SERIES DIRECTOR SHALL BE EMPOWERED TO PERMIT ANY REASONABLE AND/OR APPROPRIATE AMENDMENT FROM ANY OF THE SPECIFICATIONS AND/OR PROCEDURES HEREIN, OR IMPOSE ANY FURTHER RESTRICTIONS THAT IN THEIR OPINION DOES NOT ALTER THE MINIMUM ACCEPTABLE REQUIREMENTS. REVISIONS TO THE RULES ARE NOT INTENDED TO EXPRESS OR IMPLY THE WARRANTY OF SAFETY SHALL NOT RESULT FROM ANY SUCH DEVIATION OR RESTRICTION OF THE SPECIFICATIONS, RULES AND/OR PROCEDURES. ANY INTERPRETATION OF, DEVIATION FROM, THESE RULES HEREIN, ARE LEFT TO THE DISCRETION OF THE RACING OFFICIALS AND THEIR JURISDICTION IS FINAL. IT IS ULTIMATELY THE OBLIGATION OF EACH PARTICIPANT TO ENSURE THEIR CONDUCT AND EQUIPMENT COMPLIES WITH ALL OF THE APPLICABLE RULES, AS THEY MAY BE AMENDED FROM TIME-TO-TIME.

# <u>WEEKLY RACING PROCEDURES ARE AT THE DISCRETION OF THE HOST TRACK. THE BELOW</u> <u>PROCEDURES APPLY AT ALL MID-EAST MODIFIED TOUR TOURING EVENTS.</u>

# 1.0 GENERAL RULES

- 1. DRUG AND ALCOHOL CONSUMPTION WILL NOT BE TOLERATED. THOSE FOUND UNDER THE INFLUENCE WHILE RACING WILL NOT RACE AND COULD FACE FINES AND/OR SUSPENSION.
- 2. EVERYONE MUST HAVE A 1099/W9 ON FILE TO PARTICIPATE
- 3. ANYTHING THAT COULD BE CONSIDERED UNSPORTSMANLIKE CONDUCT WILL NOT BE TOLERATED.
  - a. THIS INCLUDES, BUT IS NOT LIMITED TO, FIGHTING AND VERBAL ALTERCATIONS. THIS ALSO INCLUDES SOCIAL MEDIA NETWORKS, AND WILL BE LEFT UP TO THE DISCRETION OF THE SERIES STAFF.
- 4. THOSE USING INAPPROPRIATE AND/OR FOUL LANGUAGE TOWARDS ANOTHER COMPETITOR OR FAN MAY RECEIVE ONE WARNING, AFTER THAT YOU WILL BE DISQUALIFIED, WITH NO POINTS OR MONEY BEING AWARDED.
- 5. CURSING OR ASSAULTING ANY MID-EAST MODIFIED TOUR SERIES OFFICIAL WILL RESULT IN AN AUTOMATIC DISQUALIFICATION, AND/OR SUSPENSIONS/PENALTIES. THIS WILL BE LEFT UP TO THE SERIES DIRECTOR'S DISCRETION.
- 6. ALL CARS ENTERED INTO MID-EAST COMPETITION MUST PAY THE \$50 YEARLY WEEKLY MEMBERSHIP FEE TO MID-EAST PRIOR TO TECHNICAL INSPECTION.
- 7. MEDIA, STREAMING AND ALL OTHER DIGITAL RIGHTS ARE RESERVED TO MID-EAST AND MID-EAST MEDIA DESIGNEES.
- 8. THE RULES AND/OR REGULATIONS SET FORTH HEREIN DO NOT EXPRESS OR IMPLIED WARRANTY OF SAFETY FROM PUBLICATION OF OR COMPLIANCE WITH RULES AND/OR REGULATIONS. THESE RULES ARE INTENDED AS A GUIDELINE FOR THE CONDUCT OF MID-EAST SANCTIONED 602 MODIFIED DIVISION EVENTS, AND ARE IN NO WAY A GUARANTEE AGAINST INJURY OR DEATH TO PARTICIPANTS, SPECTATORS, OR OFFICIALS.
- 9. THE RULES AND/OR REGULATIONS WILL APPLY TO ALL MID-EAST MODIFIED TOUR SANCTIONED EVENTS.

- 10. MID-EAST OFFICIALS SHALL HAVE FULL AUTHORITY OVER SAID SANCTIONED EVENTS, AND IN THE EVENT OF ANY DISPUTE, THE HEAD OFFICIAL'S DECISION WILL BE FINAL.
- 11. ALL COMPETITORS AND CARS ARE SUBJECT TO INSPECTION BY MID-EAST TECHNICAL INSPECTORS OR THEIR REPRESENTATIVES AT ANY TIME DURING ANY EVENT.
- 12. MID-EAST, AND IT'S OFFICIALS AND REPRESENTATIVES RESERVE THE RIGHT TO CONFISCATE ANY SUSPICIOUS OR DEEMED ILLEGAL PARTS OR COMPONENTS.
- 13. MID-EAST RESERVES THE RIGHT TO ALTER OR AMEND THESE RULES AND/OR REGULATIONS IN THE INTEREST OF FAIR COMPETITION, EFFICIENT COMPLETION OF AN EVENT, OR FOR SAFETY. ALL OFFICIAL'S DECISIONS ARE FINAL.
- 14. IN ADDITION TO THIS RULE BOOK, CRATE RACIN' USA SUSPENSIONS AND FINES WILL BE UPHELD IN THE "MID-EAST REGION".

# 2.0 RACING RULES

- 1. RACING RULES INCLUDING STARTS, RESTARTS ETC ARE AT THE DISCRETION OF THE MID EAST RACE DIRECTOR.
- 2. TOURING SERIES PROCEDURES \$50 ENTRY FEE ALL EVENTS.
- 3. ALL CARS MUST SIGN IN AND DRAW BEFORE DRIVERS MEETING.
- 4. ALL CARS MUST BE IN LINE FOR QUALIFYING ON TIME. ANY CAR THAT MISSES QUALIFYING SPOT WILL RECEIVE 1 LAP AT THE END OF TIME TRIALS AND CAN QUALIFY NO BETTER THAN HALF +1 IN THEIR GROUP.
- 5. ANY DRIVER TAKING AN EXTRA LAP QUALIFYING WILL BE DOCKED 5 POSITIONS FROM FASTEST QUALIFYING LAP.
- 6. ALL CARS MUST BE DRIVEN FROM STAGING ONTO TRACK.
- 7. ALL CARS SCALE FOLLOWING QUALIFYING LAPS.
- 8. ALL STARTS WILL BE DOUBLE FILE (SERIES RESERVES RIGHT TO ADJUST FOR TIME OR TRACK CONDITIONS.
- 9. POLE SETTER STARTS RACE (IF POLE MAN TAKES OUTSIDE POLE, STILLS STARTS RACE)
- 10. ALL RESTARTS WILL BE "CHOOSE" LINE UP.
- 11. THIS IS YOUR WARNING FOR JUMPING ANY START. ANYONE JUMPING WILL BE PUT BACK 1 ROW OR 2 SPOTS.
- 12. LEADER MUST KEEP PACE LAP SPEED THROUGH RESTART.
- 13. ALL CARS INVOLVED IN CAUTION GO TO REAR, FROM INITIAL START LAST RESTART.
- 14. 2 COURTESY LAPS FOR FLAT TIRE IN FEATURE ONLY. MUST BE ON LEAD LAP FOR COURTESY LAPS.
- 15. MID-EAST OFFICIALS (OR TRACK OFFICIALS) DO NOT PULL SHEET METAL.
- 16. ANY DRIVER THAT SPINS, SLOWS, ETC BUT DOES NOT STOP THAT CAUSES A CAUTION WILL BLEND IN LINE WHERE THEY ARE AT TIME OF CAUTION.
- 17. ANY CAR NOT IN LINE ON TIME FOR ANY EVENT (QUALIFYING, HEAT, FEATURE) WILL MOVE TO REAR.
- 18. DRIVERS MUST HOT LAP IN QUALIFYING GROUP.

#### 3.0 RACING PROCEDURES

- 1. RACE PROCEDURES ARE AT THE DISCRETION OF THE HOST TRACK FOR WEEKLY RACING.
- 2. TOURING SERIES WILL BE GONE THROUGH AT DRIVER'S MEETINGS.

#### 4.0 POST-RACE INSPECTION

- 1. TO PROMOTE A COMPETITIVE ENVIRONMENT THE TOP 5 WILL BE SUBJECT TO TECHNICAL INSPECTION AT ANY TIME.
- 2. HOST TRACK TECH PROCEDURES MAY APPLY.
- 3. THOSE FAILING TO TECH WILL BE DISQUALIFIED AND/OR SUSPENDED ACCORDING TO THE RULE BOOK.
  - a. DRIVERS WILL BE GIVEN 30 MINUTES OF COOLDOWN AND 1 HOUR AFTER THE PROTEST IS FILED TO PRESENT THE PART(S)

#### 5.0 PROVISIONALS

- 1. PROVISIONALS ARE AT THE DISCRETION OF THE HOST TRACK FOR WEEKLY RACING.
- 2. TOURING SERIES PROCEDURES WILL BE BASED OFF SEASON POINTS AND MUST BE PAID 2025 MID-EAST MODIFIED TOUR MEMBER TO RECEIVE PROVISIONAL.

#### 6.0 AMENDMENTS/REVISIONS FOR 2020

1. ALL REVISIONS WILL BE HIGHLIGHTED IN RED AND LISTED IN SECTION 6.0

#### 7.0 POINTS AND INCIDENT POINTS

1. 2025 POINTS FUND CRITERIA

- a. DRIVERS MUST COMPETE IN 7 REGULAR SEASON AND ALL CHAMPIONSHIP EVENTS DURING THE 2025 MID-EAST MODIFIED TOUR SEASON TO BE ELIGIBLE TO RECEIVE BANQUET AWARDS OR SPECIAL CATEGORY AWARDS FOR THE 2025 CHAMPIONSHIP.
- b. DRIVER MUST BE A PAID 2025 MID-EAST MODIFIED TOUR MEMBER FOR YEAR END AWARDS.
- 2. EARNING POINTS
  - a. EVERY DRIVER RECEIVES SOME POINTS AS LONG AS THEY PAY THE MEMBERSHIP FEE, ENTRY FEE AND ARE DOCUMENTED AS COMPLETING IN (*AT LEAST*) TIME TRIALS, A HEAT RACE, OR A B-MAIN.
  - b. ALL NON TRANSFER OR DNS (DID NOT START) CARS WILL RECEIVE 10 POINTS.
  - c. MUST ATTEND YEAR END BANQUET TO RECEIVE MONEY AND AWARDS.

# 8.0 INCIDENT POINTS

- 1. INCIDENT POINTS AND REMOVAL FROM RACING SURFACE ARE AT THE DISCRETION OF THE HOST TRACK FOR WEEKLY RACING.
- 2. TOURING SERIES PROCEDURES COMING SOON.

# <u>9.0 DECALS</u>

- 1. DECAL AND CONTINGENCY REQUIREMENTS
  - a. THERE ARE CERTAIN DECALS THAT WILL BE ISSUED TO YOU AT EACH RACE AND MUST BE CARRIED ON THE CAR; IN ORDER TO EARN BOTH POINTS TOWARDS THE SEASON ENDING CHAMPIONSHIP PAYOUT AND EVENT PRIZE MONEY. THE SERIES IS AWARE OF AND HAS NO WISH TO CAUSE CONFLICTS BETWEEN DRIVERS, TEAMS AND YOUR SPONSORS. THESE DECALS MUST BE PRESENT ON THE CAR FOR CONSIDERATION FOR SEASON ENDING CHAMPIONSHIP POINTS FUND. THESE DECALS MUST BE POSITIONED ON THE CAR SIDES. THE MID-EAST 604 LATE MODELS SHIELD MUST BE IN PLACE AT ALL EVENTS. THE SHIELD MUST BE PLACED ON THE FENDER ON THE RIGHT AND LEFT SIDES. COLORS MAY NOT BE CHANGED WHATSOEVER.
  - b. DRIVERS WILL RECEIVE 1 EVENT GRACE PERIOD TO GET THEIR CARS WITH OUR DECALS IN COMPLIANCE WITH THE RULE BOOK. OTHERWISE THEY ARE SUBJECT TO FORFEIT CHAMPIONSHIP POINTS PER EVENT. (ALL LOGOS CAN BE FOUND IN THE DRIVE OR ON OUR WEBSITE AND ARE ALSO AVAILABLE AT THE TRACK.)

# 10.0 MEMBERSHIP

- ALL DRIVERS PARTICIPATING AT MID-EAST MODIFIED TOUR SANCTIONED TRACKS AND EVENTS MUST PURCHASE AN ANNUAL MEMBERSHIP AT A COST OF \$100 PER YEAR. THIS MEMBERSHIP MAKES THE DRIVER ELIGIBLE FOR POINTS FUND MONIES AND CONTINGENCY AWARDS.
- MEMBERSHIPS ARE CONSIDERED LICENSED AND CAN BE REVOKED AT ANY TIME AT THE SANCTIONING BODY'S DISCRETION.
- 3. IN ADDITION TO THE REQUIRED MEMBERSHIP FEE, DRIVERS MAY BE SUBJECT TO TRACK ENTRY FEES ETC.

# 11.0 602 MODIFIED RULES

11.0.1 SAFETY: ANY CAR DEEMED UNSAFE OR UNFIT FOR COMPETITION MAY NOT PARTICIPATE. MINOR INFRACTIONS WILL BE ISSUED A ONE (1) WEEK "FIX IT NOTICE"

- 1. ALL BALLAST MUST BE SECURELY FASTENED WITH BOLTS AND/OR WEIGHT CLAMPS. DUCT TAPE AND ZIP TIES ARE NOT ACCEPTABLE. MUFFLER CLAMPS ARE NOT ACCEPTABLE. 1 MOUNTING POINT PER 25LBS REQUIRED.
- 2. BALLAST MUST BE PAINTED WHITE WITH CAR # DISPLAYED. ANY LEAD OR WEIGHT THAT COMES OFF OF A CAR IS SUBJECT TO A \$5/LB FINE.
- 3. MUST HAVE WORKING FIRE EXTINGUISHER IN CAR, UNLESS RUNNING FIRE SUPPRESSION SYSTEM.
  - a. FIRE SUPPRESSION SYSTEM WILL BE MANDATORY IN THE FUTURE, PLEASE INVEST IN ONE OVER THE NEXT SEASON.
- 4. MUST HAVE SFI APPROVED 5 POINT HARNESS THAT IS IN DATE. (3 YEARS OLD MAXIMUM)
- 5. MUST HAVE A WORKING RACECEIVER/NITRO BEE/SWITCH AT ALL TIMES WHILE ON THE RACING SURFACE. TUNED TO 454.000
- 6. FULL CONTAINMENT SEATS AND HEAD RESTRAINT REQUIRED AT ALL TIMES.
  - a. RACING SEATS REQUIRED, MUST FIT DRIVER, BE SFI APPROVED, AND MUST BE BOLTED TO ROLL CAGE.
- 7. CARS DEEMED UNSAFE TO RUN OR THAT FAIL PRETECH WILL NOT BE ALLOWED TO RACE AT THE TECH OFFICIALS DISCRETION.
- 8. NO ALUMINUM OR TITANIUM CAGES OR TUBING PERMITTED. ALL TUBING MUST BE A MINIMUM OF 1 1/2 INCHES AND A MINIMUM OF .095 WALL THICKNESS. THREE BARS IN DRIVER'S SIDE MANDATORY, TWO BARS IN RIGHT SIDE

MANDATORY. MUST HAVE A MINIMUM OF 1 INCH BAR, .083 WALL THICKNESS IN HALO SECTION RUNNING EITHER FRONT TO REAR OR DIAGONAL ACROSS. MUST HAVE A ROCK GUARD WITH A MAXIMUM OF 4IN BETWEEN BARS.

# 11.1 WEIGHT:

CLAIMED WEIGHT MUST BE POSTED CLEARLY ON BOTH SIDES OF A-PILLAR OR HOOD

- 1. 2500 LBS
- 2. 1LB PER LAP BURNOFF FOR MID-EAST OR GM BOTTLE CAP SEALED ENGINES IN FEATURE ONLY.

# 11.2 CHASSIS AND FRAME:

- 1. CONVENTIONAL IMCA/UMP CHASSIS RULES.
- 2. WEIGHT JACKS MUST BE 1" FROM CENTER LINE. STOCK CLIP MUST COME PAST BACK OF ENGINE BLOCK.
- 3. FACTORY PRODUCTION US CAR FRAMES, COMPLETE FRAME IN FRONT OF FIREWALL.
- 4. FRAMES MAY NOT BE WIDENED OR NARROWED. FRONT CROSS MEMBER MAY BE NOTCHED FOR RADIATOR CLEARANCE. MINIMUM FRAME CLEARANCE 4".
- 5. WHEELBASE 108" MINIMUM, 112" MAXIMUM.
- 6. REAR OF FRAME MAY BE ALTERED TO ACCEPT LEAF OR COIL SPRINGS. NO FIBERGLASS SPRINGS OR LIFT BARS ALLOWED. NO TORSION BARS.
- 7. REAR OF BELL HOUSING FLANGE MINIMUM 72" FORWARD FROM CENTER OF AXLE.ENGINE OFFSET WITHIN 2" OF CENTERLINE OF CROSS MEMBER.
- 8. ALTERATIONS AND/OR RELOCATION OF LOWER CONTROL ARM MOUNTS WILL NOT BE PERMITTED.

**11.3 BODY ITEMS GOVERNED BY MID EAST OFFICIALS:** THOUGH THEY MAY BE PROTESTED BEFORE START OF EVENT, THE BODIES MAY BE OBSERVED, MEASURED, ETC. AS NECESSARY. IF MID EAST OFFICIALS DO NOT APPROVE, YOU WILL BE ASKED TO CHANGE IT, ADD WEIGHT OR ANYTHING DEEMED NECESSARY BY THE OFFICIALS. MID-EAST BODY RULES APPLICABLE AT ALL TIMES.

#### 1. GENERAL BODY:

- a. SEE 2025 MID-EAST MODIFIED TOUR BODY DIAGRAM.
- b. ENGINE COMPARTMENT TO BE OPEN ON BOTH SIDES. NO SIDE PANELS IN FRONT OF MOTOR PLATE.
- c. TOP OF DOORS AND DECKING MAY NOT EXTEND PAST REAR OF ENGINE BLOCK.
- d. REAR PANEL (FROM QUARTER TO QUARTER) NOT REQUIRED.
- e. NO WINGS OR SPOILER INSIDE OF CAR. COWL MAY WRAP AROUND BUT MUST ANGLE DOWN FROM STEERING WHEEL BACK.
- f. NO LIPS ON BODY OR DECKING. EXCEPTIONS: ROOF AND NOSE MAX 2" LIP ON EITHER (BOTH) SIDE.
- g. MAX 1" LIP ON FRONT OF DOORS. MUST BE TURNED INWARD.
- h. ALL RIGHT REAR QUARTER LIPS MUST TURN TO INSIDE OF CAR.
- i. DECKING MUST CARRY SAME ANGLE FROM FRONT TO REAR. 1" TOLERANCE.
- j. LEFT SIDE DECKING MUST RUN STRAIGHT FROM FRONT TO REAR. 1" TOLERANCE.
- k. REAR SPOILER NOT ALLOWED.
- I. REAR SAIL PANEL MAY NOT EXTEND FORWARD OF REAR UPRIGHT CAGE BAR.
- m. WITH THE EXCEPTION OF DZUS FASTENERS, HOOD MUST BE ABLE TO BE REMOVED WITHOUT TOOLS, 50LB PENALTY IF TOOLS ARE NEEDED.
- 2. DECK HEIGHT
  - a. MAXIMUM 39 INCHES

#### 11.4 CHASSIS & SUSPENSION:

- 1. STANDARD IMCA/UMP SUSPENSION ONLY. NO SPRING LOADED OR SHOCK TYPE 4 BAR RODS. ONLY STANDARD STEEL SOLID 4 BAR RODS.
- STANDARD IMCA/UMP SUSPENSION EQUALS ONE (1) SHOCK PER WHEEL. LEFT REAR IS ALLOWED 1 ELIMINATOR. .
  a. SHOCKS MUST BE MOUNTED VERTICAL TO AXLE TUBE.
- 3. CHAIN LIMITERS WILL BE ALLOWED; MUST MEET THE FOLLOWING CRITERIA:
  - a. SOLID CHAIN.
  - b. RUBBER PUCKS ARE PERMITTED.
- 4. NO TORSION BAR ON FRONT OR REAR SUSPENSION.
- 5. STANDARD ONE-PIECE BIRD CAGES. NO SPLIT BIRD CAGES.
- 6. CHASSIS BRACKETS MUST BE FIXED. NO MOVEMENT.

- ONE (1) MECHANICAL TRACTION DEVICE ALLOWED, EITHER 5TH COIL OR TORQUE LINK, BUT NOT BOTH. ONE (1) 90/10 ALLOWED WITH TORQUE LINK, MOUNTED CENTER TOP OF REAR END TO FRAME.
- 8. STEERING BOX MUST BOLT IN STOCK LOCATION AND BOLT PATTERN. MAY USE STEERING QUICKENER. NO CENTER STEERING OR RACK AND PINION.
- 9. ALL STEERING COMPONENTS MUST BE STOCK. OEM. NO AFTERMARKET DRAG LINKS OR CENTER LINKS. MAY USE TUBE AND HIEM STYLE TIE RODS.
- 10. POWER STEERING PUMP MAY BE MOUNTED ON THE BELLHOUSING.
- 11. STOCK PASSENGER CAR SPINDLES ONLY. NO AFTERMARKET OR FABRICATED SPINDLES. IMCA 3PC SPINDLES OK.
- 12. TUBE TYPE UPPER A FRAMES ALLOWED. MUST BE STEEL.
- 13. NO ALUMINUM SUSPENSION PARTS ALLOWED UNLESS LISTED.
- 14. OEM STYLE LOWER A FRAMES. STOCK OR AFTERMARKET (KEYSER, ALLSTAR, ETC) OK. MAY HAVE HEIM TYPE ENDS. MUST BE STOCK MEASUREMENT WITHIN HALF INCH.
- 15. MAXIMUM TREAD WIDTH FRONT OR REAR 78". ZERO TOLERANCE. MEASURED FROM OUTSIDE OF TIRE TO OUTSIDE OF TIRE. MAX 1" WHEEL SPACER ALLOWED.
- 16. LEAF SPRING, 3 LINK, OR 4 LINK REAR SUSPENSION ALLOWED.
- 17. 1 COIL SPRING PER WHEEL.
- 18. ANY COIL SPRING MUST BE AT LEAST 4 ½" OD. RIGHT FRONT SPRING MINIMUM 8" TALL. LEFT REAR SPRING MINIMUM 10" TALL.
- 19. THE UPPER FRONT COIL SPRING MUST BE FLAT AND SUPPORT THE SPRING 360 DEGREES.
- 20. THE LOWER FRONT COIL SPRING MOUNT MAY HAVE A SINGLE STEP TO PREVENT SPRING ROTATION AND ACCOMMODATE THE OPEN END OF THE SPRING. THE STEP OF THE LOWER FRONT SPRING MOUNT MAY NOT EXCEED 1" IN HEIGHT. THE LOWER SPRING MOUNT MUST BE WELDED (BOLTED) SOLID TO THE LOWER CONTROL ARM.


